# Preserving Our Tradition, Building Our Future: A Capital Campaign for Omicron Chapter is Underway!

For more than 90 years, Omicron has been the home, training ground, and anchor for over 900 brothers. We lived, played, studied and learned from each other during our years at Penn State. We are proud of our Chapter, our Legacy, and our House, and look forward to another 90 years of helping young men mature into solid citizens.

We have survived – and thrived – through wars, depressions, recessions, social upheaval, and all manner of challenges. The House has been the place where young men made lifelong friendships, learned and sharpened key life skills, and set out to build their lives and careers. Our House and Brotherhood are exceptionally strong today - thanks to the contributions of our brothers. The tireless efforts of our Board of Directors and Board of Governors, who work to improve the facilities and instill Phi Kappa Tau's tenets among our undergraduates, has developed an undergraduate chapter of over 80 young men who consistently win national and local awards for campus participation, management, philanthropy, scholarship and more.

Omicron is on a high! Help us keep it moving forward by continuing to renew and rebuild our House and by establishing educational opportunities that mold the Omicrons of tomorrow.

With our eye on the future, the Omicron Chapter of Phi Kappa Tau is excited to announce the official kick-off of our Preserving

Our Tradition, Building Our Future Capital Campaign. The campaign has three components, all of equal importance to the chapter's future success:

- \$1,000,000 for bricks and mortar improvements to our facilities,
- \$250,000 for leadership

development, and

• \$250,000 for undergraduate scholarships.

A brochure detailing the vision for the renovation, the case for scholarship dollars based on the ever rising cost of college tuition and leadership opportunities for our young actives will be forthcoming and we are asking each of more than 850 alumni to make a pledge to the campaign.

## **Looking for a Few Good Omicrons. We Want YOU!**

Whatever the motivation, we provide the Class Agent the discretion to assess the approach to each potential donor. Eventually, there were five of us from Nittany 42 in the house: Manny, Wertz, Navarra, Chervenic, and me - so you can blame us all on Jerry and Manny. Manny and I visited a few times in Canonsburg and Latrobe during Christmas and summer vacations, and I was privileged to meet his family on several occasions.

The last time Shirley and I saw Manny (and met Maria) was nine years ago when we swung down through Birmingham to visit them on the way back from one of our trailer trips across the country. We had dinner and lamented the then current dismal state of the Nittany Lions and generally had a brief but splendid reunion. How glad I am for the visit; another reminder to do it now, whatever it is, because tomorrow may be too late.

Rest well, Manny. Thank you for being part of my life. - Bill Netzlof '58


### A Word From the Omicron Board of Directors ...

## **Chapter is Fundraising Powerhouse Supporting THON**

#### What is THON?

The Penn State IFC/Panhellenic Dance Marathon is a year-long fundraising and awareness campaign for the fight against pediatric cancer. More than 350 student organizations participate in THON. These organizations include fraternities, sororities, clubs, and other student organizations. The campaign culminates with a 46 hour no-sitting, no-sleeping dance marathon known as THON Weekend. In 2013, THON raised a recordbreaking \$12.37 million and was able to donate 96% of funds raised directly to the Four Diamonds Fund.

#### The Rise of Omicron in THON

In recent years, Phi Kappa Tau Omicron has become a powerhouse in THON fundraising, raising over \$124,000 (or in other words, 1% of total THON funds) during the THON in the 2012-2013 season. This not only makes Omicron a highly respected organization in both the THON institution and university,

but also draws accolades from our Phi Kappa Tau national fraternity, where we have been the best philanthropic fundraisers for each of the last 5 years. This success reflects both the consistent dedication of our undergraduate brotherhood and generosity of our alumni base.



#### **THON Partnerships**

For the past six fundraising seasons, Phi Tau has had the pleasure of partnering with the Student Nursing Association of Pennsylvania (SNAP) for THON. Since the

start of the partnership in 2008, Phi Tau and SNAP together raised a total of over **\$457,000** and were ranked among the **top 15 Greek organizations** at THON last year.

In 2013, the undergraduate brothers made a difficult, but strategic decision to split from SNAP and pair with the sisters of Phi Mu, to engage in a more accountable partnership. To date, the paring is already showing signs of great success, **raising nearly \$50,000** in canning trips alone. This is a \$13,000 increase from the previous year to date. This year the Phi Kappa Tau **THON 2014 fundraising goal** 

is \$150,000. Our THON chairs remind us regularly, that our barrier to move into the top 10 fundraiser group is the need for corporate sponsorships, which the chapter is actively pursuing.

#### **Family Relations**

The undergraduate brothers know amidst the competitive environment of fundraising,

the most important part of THON is the relationships that we cultivate with our THON families.
Our undergrads, and specifically our THON chairs, have been extremely proactive in

engaging our sponsored families by making sure they feel welcome as part of our fraternal family. We were very excited to hear that the Beyer's and our THON child Cora would stay with us as one of our sponsored families following the split with SNAP. This was certainly a testament to our unwavering commitment to family relations. Phi Tau looks forward to continuing a strong relationship with ours and our partner's THON families for years to come.
